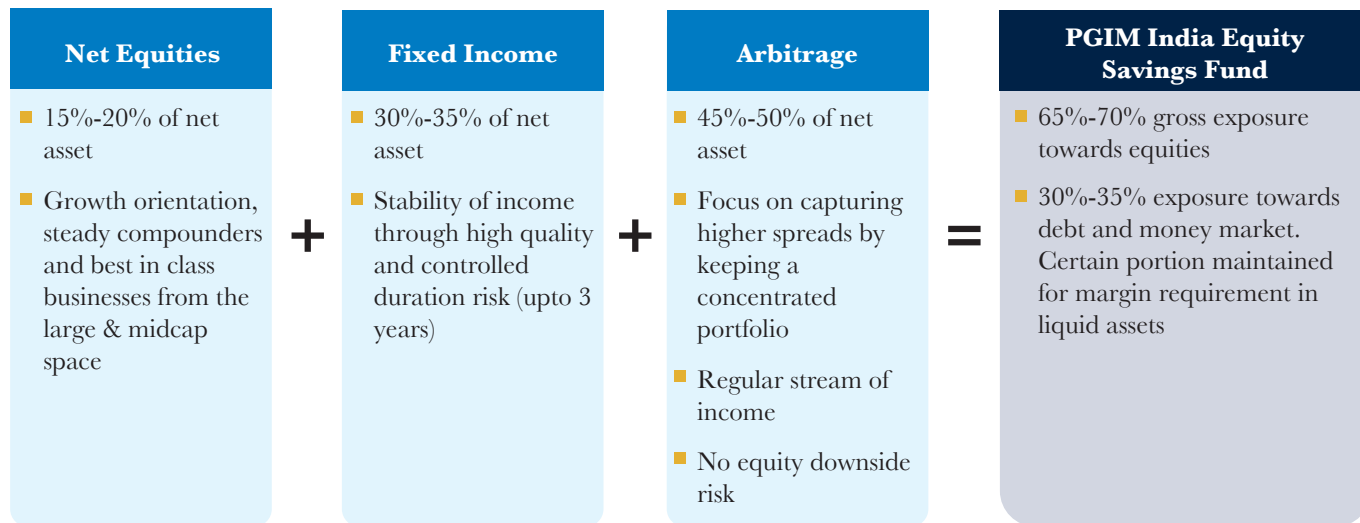

- Lower correlation with equities
- Fulfils liquidity and margin money requirement

- Liquidity and inflation trajectory needs to be watched

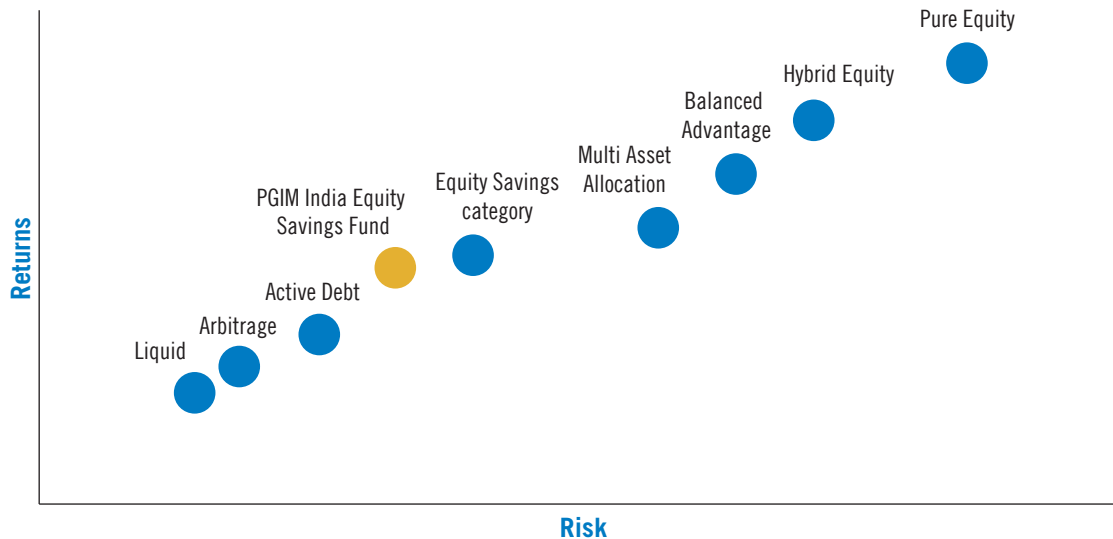
### Arbitrage

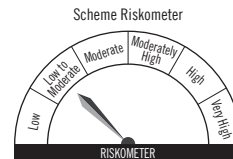
